### 2. Action Items

- a. Lisa Steindel motioned to approve the April minutes, Heather Graham seconded the motion, the motion carried
- b. Heather Graham motioned to approve the By-Laws Amendment giving termed board members another 3 year term (See Attached), Guy Costa seconded the motion, the motion carried. There was one dissent.

- d. Heather Graham motioned to approve the 2023/24 SHUC Annual Budget (See Attached), Guy Costa seconded the motion, the motion carried. (It was noted that the budget estimates will be monitored and if necessary, the treasurer will recommend that the budget be amended.)

# 3. Executive Director's Report

- a. Clean Sweep Week Update Clean Sweep Week was a big success with over 200 community members helping to clean te neighborhood, including several of our board members and their families. There were two bingo winners: the Parno and Murphy families. Merchants and local supporters included Games Unlimited, Riverstone Books, Littles, Phipps Conservancy with a family membership, the Refillery and both Starbuck's Squirrel Hill locations!
- b. JCC Center for Loving Kindness Rabbi Ron Symons announced that he will be retiring in a year, giving us time to celebrate his time here. Our partnership with CFLC remains strong, we will be a part of the plan as CFLK is reimagined.
- c. Two potential board members will be scheduled for interviews. Maria read David Vatz's and Vida Passero's resumes for the board's information.

## 4. Treasurer's Report. P & L for April

For the month of April we had contributions of \$4,670 and membership dues of 1,680 dollars, our bookkeeper will consolidate contributions in the coming year, SHUC does not have membership dues In addition to those contributions, SHUC also had magazine revenues in April of \$1,560 and sponsorship income of \$2,625 Our total income for the month was \$10,545. Our expenses for April were \$18,049, of which \$7,140 was from restricted account for planters. Our balance sheet shows about \$12,000. in our main checking account. This is lower than the \$24,000 we had last year at this time and will require us to spend carefully until funds from Treasure Dinner Sponsors are received.
