4. Fiscal Report

- a. May P & L In May, SHUC had \$6,175 in revenue, \$5k from the NIF Grant for planters and \$930 in Magazine revenue. Our expenses were \$9,947.33 which included \$1,264.25 for insurance and approximately \$800 to stock up on litter patrol supplies for all of the upcoming events. The SHUC account balance was \$9,947.33. We are in the position where we need to replenish with the Treasure Dinner sponsorships and Summer Donor campaign.
- 5. Executive Director's Report
 - a. Blue Zone Update Things are moving along with our potential Blue Zone Activate project. Phipps and the JCC are currently willing to partner if the project goes

- further. Next, we will meet with UPMC, RK Mellon, Giant Eagle, AHN and other important potential partners and funders. We will most likely need the help of several foundations and funders to support a Blue Zone Activate program in Squirrel Hill. Should we partner with a neighboring community like Hazelwood?
- b. Farmer's Market Dates SHUC was allotted 5 dates for the 2024 Farmer's Market. Here are the dates SHUC will physically have a booth at the Farmer's Markets 8/25, 9/22, 10/6 and 11/17.
- c. Volunteers Needed We have Night Markets, Farmer's Markets, tending to the garden, some other plantings and potentially Bach, Beethoven and Brunch that will all require volunteers. For the June 29th Night Market, we have representatives at the SHUC booth but still need litter patrol support and booth set up/tear down support. There will be a litter patrol pre-clean up from 9 am - 11 am on the day of the June Night Market in case you are able to support us. We also need volunteers to help support the garden at the Parkway. We are still waiting to hear from Bach, Beethoven and Brunch regarding a booth and are hoping to again share space with FOMP We are listed as a Sponsor on the site.
- d. Summer Donor Campaign The Summer Donor Campaign was mailed on Friday, 6/7 and we received our letter on Saturday, 6/8. It also went out in our newsletter. We typically earn approximately \$10k per campaign. Please help to get the word out and support us as you are able. Neighbors have already contributed \$361.
