**May board meeting-** Jan presented the Wightman Traffic Safety Project

**August board meeting** - There was a rigorous discussion by the board. At that meeting the board voted to send a letter to the acting director of DOMI with questions and concerns.

**September Executive Committee meeting** - We did not hear from DOMI and resent the letter. The letter fell through the cracks with DOMI.

**September Board Meeting** - Jan is presenting to address some of the concerns - September board meeting. The engineers looked at larger vehicles with turns in a program designed to show how trucks would be able to move. The design intent is to slow down vehicles so that pedestrians are comfortable crossing the street. What is the chance the community will understand traffic calming? The safety measurements will be more visible than Stanton Ave. with flex posts and other features.

Pedestrian safety is the top priority. The traffic calming features will slow down cars making it safer for pedestrians.

Bartlett and Beacon intersections were corrected and revised.

Proposal for DOMI to install this as soon as possible before winter.
